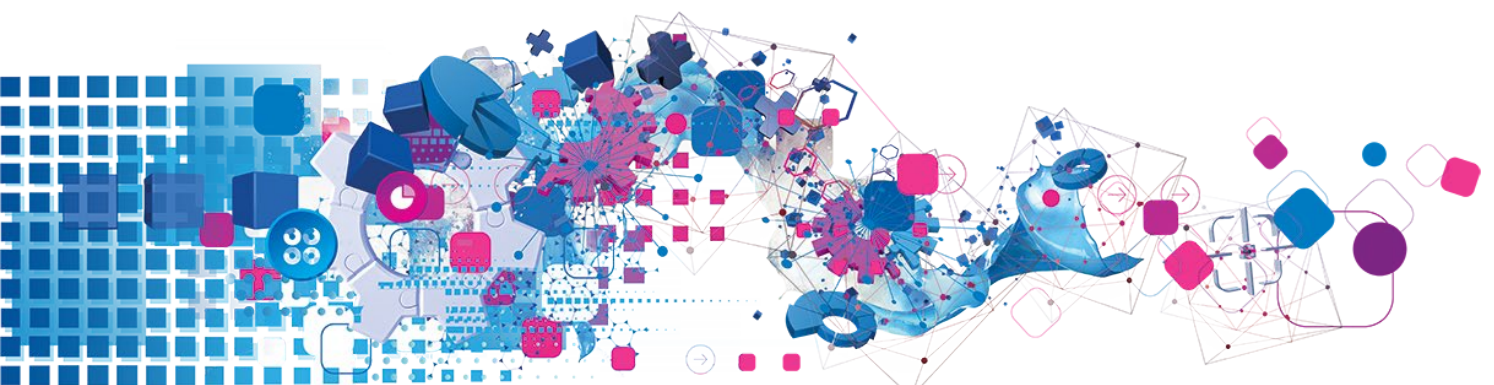

1. Introduction

This document lists the updates and hotfixes that are included in Experian Data Quality for Salesforce v6 package 6.4 released on December 2020.

2. Release notes

2.1 Fix 33589: Duplicate management not initialized if before insert/before update trigger on the object triggers duplicate rules.

Prior to the fix, if an object had a before update or before insert trigger which would trigger the configured Salesforce Duplicate Rules, no message would appear indicating there were any duplicates.

Affected: Lightning Experience, Dynamic Page override

2.2 Fix 160669: Duplicate management custom alert text is not shown and generic text is used.

Prior to the fix, if custom alert text had been configured in the Salesforce Duplicate Rules it would not be shown in the duplicate management modal, with the default generic text shown instead.

Affected: Lightning Experience, Dynamic Page override

2.3 Fix 163459: Global Picklist does not allow record to be saved with user language other than English.

Prior to the fix, if a Global Picklist was configured with non-English values it would prevent the record from being saved.

Affected: Classic, Dynamic Page override

2.4 Fix 162373: Classic Console tabs renamed “External Page” on save.

Prior to this fix, if the New or Edit buttons were overridden and a new or existing record saved the tab would be renamed from its correct value to “External Page”.

Affected: Classic Console, Dynamic Page Override, Detail Page Override

2.5 Fix 21409522: Fields in Edit modal obscured by Save and Cancel buttons.

Prior to this fix, if the non-page override was used a record was edited, the last few fields in the modal window would be hidden behind the Save and Cancel buttons.

Affected: Lightning Experience, Dynamic Page override, Chrome v86

2.6 Fix 21384366: Page fully refreshing following save of record.

Prior to this fix, upon editing and saving a record, the whole page would be refreshed with the Dynamic Page Override in place rather than simply closing the modal.

Affected: Lightning Experience, Dynamic Page override
